THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to the proposal of the Austrian Government,

Whereas:

- (1) On 10 December 2019, 20 January 2020 and 3 February 2020, the Council adopted Decisions (EU) 2019/2157<sup>1</sup>, 2020/102<sup>2</sup> and 2020/144<sup>3</sup> appointing the members and alternate members of the Committee of the Regions for the period from 26 January 2020 to 25 January 2025.
- (2) A member's seat on the Committee of the Regions has become vacant following the end of the term of office of Ms Barbara EIBINGER-MIEDL.
- (3) An alternate member's seat has become vacant following the end of the term of office of Ms Doris KAMPUS,
