Dear Council of the European Union,

Please pass this on to the person who reviews confirmatory applications.

I am filing the following confirmatory application with regards to my access to documents request

'Council of the EU engagement with and policy on Chinese information and communications

technology firms'.

I find it difficult to believe that the Council holds no relevant documents or other records requested

pertaining to the issue identified in my request. For instance, the Council Conclusions of December

3rd 2019 specifically addressed the issue of 5G security risks and mitigation of these. Huawei, and

Chinese telecommunications firms generally, have long been a part of the discussion within Europe

around these. At a minimum, drafting of these Council Conclusions will have involved actors and

processes referred to in my original request and I would expect have created a paper trail. This is

but one example wherein the Council has been involved in the articulation of policies that are

directly and/or indirectly related to Chinese ICT firms and their presence in Europe.

Consequently, I would like the request to be re-examined.
