Whereas:

- (1) By its Decision of 24 February 2022<sup>3</sup> the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2025.
- (2) A seat as alternate member in the governments' representatives category has fallen vacant as a result of the resignation of Ms Viktoria BERGSTRÖM.
- (3) The government of Sweden has nominated a candidate for the vacant seat,
