1. The General Secretariat of the Council has been informed of the resignation of Ms Boel CALLERMO as member of the Management Board of the above agency in the governments' representatives category (for Sweden).
2. Under Article 4 of Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94, members of the Management Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Sweden has nominated the following candidate for this seat for the remainder of the current term of office, ending on 31 March 2023:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/126 of the European Parliament and of the Council establishing the European Agency for Safety and Health at Work (EU-OSHA), and repealing Council Regulation (EC) No 2062/94<sup>1</sup>, and in particular Article 4 thereof,

Whereas:

1. In its Decisions of 9 April 2019<sup>2</sup>, 6 June 2019<sup>3,4</sup> and 8 July 2019<sup>5</sup>, the Council appointed the members and alternate members of the Management Board of the European Agency for Safety and Health at Work for the period from 1 April 2019 to 31 March 2023.
2. A seat as member in the governments' representatives category has fallen vacant as a result of the resignation of Ms Boel CALLERMO.
3. The government of Sweden has nominated a candidate for the vacant seat,
