“Slovenia can agree with the proposal of the Regulation and makes the following statement: The footnote to the point (9) - Coastal waters of Slovenia in the Annex to the proposal of a Regulation clearly states when the regime in the provision of Annex I is to be applied. This provision is the same as the relevant provision in the Croatian Accession Treaty, which is a result of the accession negotiations with Croatia. The judgment in Case C-457/18 does not modify or change this provision.”

“Croatia can agree with the proposal of the Regulation, in a compromise text as presented by the Council Presidency for negotiations with the European Parliament (6848/1/22 REV 1), including footnotes to point (7) - Coastal waters of Croatia, and point (9) - Coastal waters of Slovenia, of Annex I to the proposed Regulation, which, in the spirit of compromise, remain identical to the footnotes contained in Annex I to Regulation (EU) No 1380/2013 currently in force. This is without prejudice to the Croatian position that the conditions for the application of this reciprocal regime between Croatia and Slovenia should be fully met upon definitive settlement of the border between them, consistent with international law and by using all possible peaceful means of settlement. ¹”

Statement by Belgium, supported by Greece

“La Belgique accueille favorablement la proposition de la Commission européenne d'actualiser et d'améliorer l'efficacité de la politique européenne relative à la protection de l'environnement par le droit pénal.

Toutefois, nous insistons avec force sur la nécessité d'une plus grande flexibilité en ce qui concerne les sanctions pour les infractions maritimes, notamment les actes illicites relatifs au recyclage des navires et aux rejets par les navires de substances polluantes (article 3, §2, points g et h). À l'instar des sanctions à l'encontre des personnes morales, il est essentiel d'apporter des améliorations afin que les États Membres puissent privilégier des procédures efficaces de poursuites administratives à l'encontre des personnes physiques. However, we strongly insist on the need for greater flexibility regarding the penalties for maritime offences, including illegal acts relating to ship recycling and ship-source discharges of polluting substances (article 3(2)(g) and (h)). Similar to the sanctions for legal persons, improvements are essential to allow Member States to prioritize effective administrative procedures against natural persons over criminal procedures. Article 5 of the proposal should therefore refer to effective, proportionate and dissuasive criminal or 'non-criminal' sanctions for natural persons.

Belgium insists that this request should be duly and seriously taken into account in future negotiations on Article 5 of the proposal.”

Joint statement by Cyprus and Malta

“Malta and Cyprus welcome the proposal of the European Commission to update and improve the efficiency of the European policy on the protection of the environment through criminal law.

Although we are of the view that Article 3(2)(g) and (h) should have remained outside the scope of this Directive, in the spirit of compromise, we can support the compromise text proposed by the Presidency with the aim of reaching a partial general approach on Articles 2, 3 and 4 during the Justice and Home Affairs Council on 9 June 2022.

However, we strongly insist on the need for greater flexibility regarding the penalties for maritime offences, including illegal acts relating to ship recycling and ship-source discharges of polluting substances (Article 3(2)(g) and (h)). Similar to the sanctions for legal persons, improvements are essential to allow Member States to prioritize effective administrative procedures against natural persons over criminal procedures. Article 5 of the proposal should therefore refer to effective, proportionate and dissuasive criminal or 'non-criminal' sanctions for natural persons.

Statement by Hungary

"Hungary is convinced that water is essential for sustainable development, especially in terms of the eradication of poverty and hunger, public health, combating desertification and biodiversity loss and to ensure the promotion of a socially, economically and environmentally sustainable, resilient and inclusive future. Hungary is firmly committed to pursuing and implementing the Sustainable Development Goals (SDGs), including SDG 6 on water and sanitation, which seeks to ensure safe drinking water and sanitation for all, focusing on the sustainable management of water resources, wastewater and ecosystems and acknowledging the importance of an enabling environment.

In line with Hungary's International Development Cooperation Strategy for the period 2020-2025 ([IDC2025](#)), Hungary prioritizes development cooperation projects pertaining to water management and sanitation. According to preliminary data, in 2021, Hungary dedicated 10.72 million euros to water sector projects in developing countries.

The Second High-Level International Conference on the International Decade for Action is an important step towards the UN 2023 Water Conference strengthening the political commitment of the international community to address water-related challenges.

In spite of the importance of the objectives highlighted in the Final Declaration of the Dushanbe Conference, Hungary would like to express its concern regarding the wording on quotas in the text and would prefer to mention non-binding initiatives and bottom-up approach to promote the participation of women in all level of decision making. Hungary believes that proper education should give educated women a better chance to run for positions of responsibility. Equality between women and men should not be achieved by artificially created numerical quotas, but by empowering women. For this reason, in case the final version of the Declaration will contain a reference to quotas in the section '*D. Enhance collaboration across sectors, improve knowledge and education and develop instruments and technologies*', Hungary does not oppose the adoption of the document, but interprets the relevant paragraph in line with its national legislation and circumstances."
