#### Whereas:

- (1) In its Decisions of 21 September 2020<sup>4</sup> and 19 October 2021<sup>5</sup>, the Council appointed the members and alternate members of the Advisory Committee for the Coordination of Social Security Systems for the period ending on 19 October 2025.
- (2) A seat as member in the governments' representatives category has fallen vacant as a result of the resignation of Mr Giovanni CALABRÒ.
- (3) The government of Italy has nominated a candidate for the vacant seat,
