Subject:	COUNCIL DECISION authorising the opening of negotiations with Canada for an Agreement on the general principles for the participation of Canada in Union programmes and on the association of Canada to Horizon Europe – the Framework Programme for Research and Innovation (2021-2027) - Adoption

1. On 30 May 2022, the Commission submitted to the Council a recommendation for a Council decision authorising the opening of negotiations with Canada for an agreement on the general principles for the participation of Canada in Union programmes and on the association of Canada to Horizon Europe – the Framework Programme for Research and Innovation 2021-2027¹.
2. The decision will allow the Commission to open negotiations with Canada on its participation to Union programmes and in particular to Horizon Europe.
3. The Research Working Party met once to examine the text.

4. The draft decision specifies that the role of the special committee, which the Commission has to consult during the negotiations with Canada in accordance with Article 218(4) TFEU, should be exercised by both the Working Party on Transatlantic Relations for matters related to the general conditions for the participation of Canada in any Union programmes and the Research Working Party for matters related to the specific conditions for the participation of Canada to the Horizon Europe programme.
5. For this reason, the Commission presented its proposal to the Working Party on Transatlantic Relations.
6. The Committee of Permanent Representatives provided further guidance², authorising the opening of negotiations for an agreement covering both the conditions for participation of Canada in any Union programme and the conditions for its participation in Horizon Europe, the latter conditions being included in the form of a protocol to the main agreement.
7. The Committee of Permanent Representatives recommended in particular that for future agreements on the participation of third countries in Union programmes, the inclusion of the protocol on the association of third countries to Horizon Europe is exceptional and should not create any precedent. This position should be set out in a statement by the Council.
8. The Research Working Party agreed on the text following written consultation that was concluded on 19 July 2022.
9. In view of the above, the Council is invited, in part "A" of the agenda of a forthcoming meeting, to adopt the Council decision authorising the opening of negotiations with Canada for an agreement on the general principles for the participation of Canada in Union programmes and on the association of Canada to Horizon Europe – the Framework Programme for Research and Innovation 2021-2027, as revised by the lawyer-linguists and set out in document 11436/22, the negotiating directives as set out in document ST 11436/22 ADD 1.
