Subject:	Council position on draft amending budget No 4 to the general budget for 2022: Update of revenue following the revised forecast of own resources and other revenue and other technical adjustments
	- Adoption

1. On 1 July 2022, the <u>Commission</u> submitted to the Council draft amending budget (DAB) No 4 to the general budget for 2022.

The main objective of DAB No 4/2022 is to update the revenue side of the budget to take account of the latest developments:

- the updated own resources forecasts for the budget 2022 agreed by the Advisory Committee on Own Resources (ACOR) on 23 May 2022;
- to update other revenues such as the United Kingdom contribution, fines and other.

Additionally, DAB No 4/2022 includes two specific adjustments related to expenditure:

- adjustment of the budgetary nomenclature following the new possibilities for Member States to transfer resources of their initial European Regional Development Fund (ERDF), Cohesion Fund (CF), European Social Fund Plus (ESF+) and European Maritime, Fisheries and Aquaculture Fund (EMFAF) allocations to the REPowerEU chapter of the Recovery and Resilience Facility (RRF) following the Commission proposal for REPowerEU on 18 May 2022¹;
- the additional staff requested for Eurojust following the extension of its mandate to
 collect and preserve war crime evidence². The related appropriations in 2022 will be
 financed through internal redeployment, and therefore no additional financing is
 required for this purpose.
- 2. The <u>Budget Committee</u> examined DAB No 4/2022 at its meetings on 7 July and on 6 September 2022, and was able to accept it without any changes.
- 3. At the close of its examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the Council's position on DAB No 4/2022 as set out in point 2,
 - instruct the Presidency to prepare the budgetary documents to be sent to the
 European Parliament and to approve the draft letter in the Annex to that effect, and
 - have the Council Decision adopting the Council's position on draft amending budget
 No 4 of the European Union for the financial year 2022, as set out in document
 12093/22, published in the Official Journal of the European Union.
