Subject: Correction to four draft OIV resolutions at step 7

The proposal of the Commission for a Council Decision on the position to be taken on behalf of the European Union in the International Organisation for Vine and Wine lists 20 draft OIV resolutions which Member States are to support during the OIV General Assembly of 4 November 2022.

The Commission services consider that 4 of those 20 resolutions would need to be amended to correct factual errors or inconsistencies, as follows:

CST-SCMA 20-668	7	Opinion of the OIV on total dry extract (total dry extract, total dry extract without sugars, residual extract)	X	<u>English version of draft resolution</u> Correction of last sentence as follows: « The OIV declares that the sole measurement of the total dry extract, total dry matter , sugar free dry extract or residual extract, if considered in isolation, it's not sufficient for the detection of possible frauds. » Reason: According to the title of this paragraph in bold 'total dry extract' and 'total dry matter' are synonyms.
OENO-TECHNO 14-567B2	7	Distinction between additives and processing aids – Part 2:	X	<u>English version of draft resolution</u> In the table, the following should be corrected: 4.1.10 Decanting <u>Transvasage</u>

OENO-TECHNO 14-567C1	7	Distinction between additives and processing aids - Skimmed milk	X	<u>English version of draft resolution</u> To avoid confusion, the same term (either “skim milk” or “skimmed milk”) should be used throughout the resolution, i.e. in the title, in the table and in the footnote. Since the term «skim milk» is used in OIV file 3.2.1, we believe that this term should also be used in the draft resolution.
OENO-TECHNO 20-684B	7	Use of selective plant fibres in musts	X	<u>English version of draft resolution</u> The definition should be modified as follows: <i>“Definition:</i> Use in musts of a selective absorbent <u>adsorbent</u> composed of plant fibres.”
