1. The General Secretariat of the Council has been informed of the resignation of Mr Andreas SOMMER MØLLER as alternate member of the Management Board of the above Foundation in the governments' representatives category (for Denmark).
2. Under Article 4 of Regulation (EU) 2019/127 of the European Parliament and of the Council establishing a European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75, members of the Management Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing a European Foundation for the improvement of living and working conditions (Eurofound)<sup>1</sup>, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019<sup>2</sup>, 25 June 2019<sup>3</sup>, 8 July 2019<sup>4</sup>, 16 September 2019<sup>5</sup> and 14 June 2021<sup>6</sup>, the Council appointed the members and alternate members of the Management Board of the European Foundation for the Improvement of Living and Working Conditions for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as alternate member in the governments' representatives category has fallen vacant as a result of the resignation of Mr Andreas SOMMER MØLLER.
- (3) The government of Denmark has nominated a candidate for the vacant seat,
