Having regard to Regulation (EU) 2019/128 of the European Parliament and of the Council establishing a European Centre for the Development of Vocational Training (Cedefop), and repealing Council Regulation (EC) No 337/75¹, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019², 8 July 2019³, 16 September 2019⁴ and 8 November 2019⁵, the Council appointed the members and alternate members of the Management Board of the European Centre for the Development of Vocational Training for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as member in the trade unions' representatives category has fallen vacant as a result of the resignation of Mr Ivan ŠÓŠ.
- (3) The trade unions' organisation ETUC has nominated a candidate for the vacant seat,
