Appointment of Ms Inja OGRIZOVIĆ DŽAMONJA, alternate member for Croatia, in place of Ms Narcisa MANOJLOVIĆ, who has resigned

---

1. The General Secretariat of the Council has been informed of the resignation of Ms Narcisa MANOJLOVIĆ as alternate member of the Management Board of the above Foundation in the governments' representatives category (for Croatia).
2. Under Article 4 of Regulation (EU) 2019/127 of the European Parliament and of the Council establishing the European Foundation for the improvement of living and working conditions (Eurofound), and repealing Council Regulation (EEC) No 1365/75, members of the Management Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Croatia has nominated the following candidate for this seat for the remainder of the current term of office, ending on 31 March 2023:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) 2019/127 of the European Parliament and of the Council of 16 January 2019 establishing the European Foundation for the improvement of living and working conditions (Eurofound)<sup>1</sup>, and in particular Article 4 thereof,

Whereas:

- (1) In its Decisions of 9 April 2019<sup>2</sup>, 25 June 2019<sup>3</sup>, 8 July 2019<sup>4</sup>, 16 September 2019<sup>5</sup> and 14 June 2021<sup>6</sup>, the Council appointed the members and alternate members of the Management Board of the European Foundation for the Improvement of Living and Working Conditions for the period from 1 April 2019 to 31 March 2023.
- (2) A seat as alternate member in the governments' representatives category has fallen vacant as a result of the resignation of Ms Narcisa MANOJLOVIĆ.
- (3) The government of Croatia has nominated a candidate for the vacant seat,
