

Non-Paper of the European Commission in relation to the point in the OIV agenda of the General Assembly of 4 November 2022 concerning the modification and adaptation of OIV's Internal Rules

By letter of 29 July 2022, the OIV Director General informed OIV member states of his decision to initiate the procedure of article 28 of the Internal Rules to amend or complete these, after the Executive Committee's favourable opinion, and provided them with proposals to modify the OIV Internal Rules of Procedure.

These modifications concern:

- the representation of Presidents,
- the functioning of electronic working groups,
- the Rules Committee,
- the effective participation or presence and
- the housing allocation.

They should be presented to the General Assembly of 4 November 2022 in Mexico.

The European Commission considers that these proposals do not raise concerns in terms of effects for the European Union legal order.

Therefore, they could be supported by the EU in the OIV General Assembly of 4 November 2022.
