- the <u>Lithuanian delegation</u> requested two items, under "any other business", on (1) a joint non-paper by Estonia, Latvia and Lithuania regarding permanent grassland, and on (2) the prolongation of the Temporary Crisis Framework for State Aid measures to support the economy following the aggression against Ukraine by Russia.
- the <u>Austrian delegation</u> requested an item, under "any other business", on the rising carnivore populations in Europe and the challenges for agriculture and rural areas.
- the <u>Polish delegation</u> requested an item, under "any other business", to inform the Council about the meeting of the Ministers of Agriculture of Estonia, Hungary, Latvia, Lithuania, Poland, Romania, Slovakia and the EU Commissioner for Agriculture during the International Dairy Cooperatives Forum on 8 September in Białystok
- <u>the SCA</u> agreed that the AOB items requested by the Austrian and Polish delegations will be held in public session, in accordance with Article 8(2) of the rules of procedure of the Council.
