d) Detailed grounds for the decrease

The decrease is mainly due to slower recruitments to the Standing Corps, lower spending on return activities, office rental costs and agency equipment costs.

Frontex is in the middle of its growth path as defined in the Regulation (EU)2019/1896 of 13 November 2019 on the European Boarder and Coast Guard. Over the past few years, the agency has made substantial improvements to achieve its recruitment targets, resulting in a strongly decreasing vacancy rate. The Agency's budget has increased continuously, and the Agency has encountered several challenges in implementing this increasing budget. However, when assessing the annual budget performance of the Agency in the framework of this steep increase in its annual budget, the agency's implementation track record is evolving positively.
