THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 209, in conjunction with Article 218(6), point (a)(iii) thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament,¹

Whereas:

- (1) In accordance with Council Decision (EU) 2022/...¹⁺, the Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and the Kingdom of Thailand, of the other part, (the ‘Agreement’) was signed on behalf of the Union on ...⁺⁺, subject to its conclusion at a later date.
- (2) The aim of the Agreement is to strengthen the cooperation across a wide spectrum of policy fields, including human rights, non-proliferation of weapons of mass destruction, counter-terrorism, the fight against corruption and organised crime, trade, migration, the environment, energy, climate change, transport, science and technology, employment and social affairs, education and agriculture.
- (3) The Agreement should be approved on behalf of the Union,

HAS ADOPTED THIS DECISION:

Article 1

The Framework Agreement on Comprehensive Partnership and Cooperation between the European Union and its Member States, of the one part, and the Kingdom of Thailand, of the other part (the ‘Agreement’),¹ is hereby approved on behalf of the Union.

Article 2

The President of the Council shall, on behalf of the Union, give the notification provided for in Article 59(1) of the Agreement.²

Article 3

The High Representative of the Union for Foreign Affairs and Security Policy shall chair the Joint Committee as provided for in Article 52(2) of the Agreement. The Union or, as the case may be, the Union and the Member States, shall be represented in the Joint Committee, depending on the subject matter.

This Decision shall enter into force on the date of its adoption.
