d) Detailed grounds for the decrease

In line with point 20 of the Inter-Institutional Agreement on the 2021-2027 Multiannual Financial Framework, amounts provided for in the budget for new fisheries agreements or for the renewal of fisheries agreements, which enter into force after 1 January of the financial year concerned, shall be included in the reserve.

It is proposed to transfer an amount of EUR 4 million in commitment appropriations from the reserve to the operational budget line for Sustainable Fisheries Partnership Agreements (SFPA) (08 05 01) to cover the financial obligations resulting from the signing and concluding of a Protocol implementing the SFPA between the European Union and the Republic of Mauritius, as well as, to cover additional catches related to financial year 2022 as set out in the relevant SFPAs and Protocols for the Government of Greenland and the Democratic Republic of Sao Tomé and Príncipe.

d) Detailed grounds for the increase

The reinforcement of the operational line for Sustainable Fisheries Partnership Agreement (SFPA) by EUR 4 million in commitment appropriations is necessary to honour the 2022 financial obligations of EUR 725 000 stemming from the signing and concluding of a Protocol implementing the SFPA between the European Union and the Republic of Mauritius, as well as, to cover additional catches related to financial year 2022 as set out in the relevant SFPAs and Protocols for the Government of Greenland and the Democratic Republic of Sao Tomé and Príncipe for an amount of EUR 3,2 million.

Further to the Commission proposal to the Council (COM(2022) 421 of 16 September 2022) on the signature of a new protocol with Mauritius, the Council decision, which serves as a legal basis for the signature of the agreement, is expected to be adopted early November. The Protocol will then enter into provisional application upon signature by both parties at the end of November 2022, which will enable committing the 2022 financial contribution.
