Delegations will find attached here a <u>corrigendum</u> of the Presidency text on the *draft Council* conclusions on European Agenda for Tourism 2030, with a view to the Working Party on Competitiveness and Growth (Tourism) meeting on 28 October 2022.

Changes in relation to the previous version (13326/22) are indicated as follows: new text is in **bold and underlined** and deletions are in **strikethrough**.

The modifications introduced in this corrigendum are as follows:

1. In point 15, the last part has been put in square brackets pending the publication of the Commission proposal:

[; in this context, TAKES NOTE of the Commission proposal on a common EU regulatory framework for short-term accommodation rentals]

- 2. In point 21.b), the text has been reverted to the previous version, and now reads:
 - "b) provide user-friendly and regularly updated travel information in exceptional situations, including through the Re-open EU platform;"

Draft Council <u>c</u>Conclusions on 'European Agenda for Tourism 2030'

THE COUNCIL OF THE EUROPEAN UNION,

HAVING REGARD to Article 195 and Article 6 of the Treaty on the Functioning of the
European Union, as regards the EU supporting, coordinating and supplementing the actions of
Member States in the area of tourism, and with due regard to the respective spheres of
competence of the Member States and the Union, as well as the principles of subsidiarity and
proportionality.

2. RECALLING

- its <u>c</u>Conclusions on 'The competitiveness of the tourism sector as a driver for sustainable growth, jobs and social cohesion in the EU for the next decade' of 27 May 2019¹;
- its <u>c</u>Conclusions on 'Tourism in Europe for the next decade: sustainable, resilient, digital, global and social' of 27 May 2021², where the Council invited the Commission and Member States, in participation with relevant stakeholders, to design a European Agenda for Tourism 2030/2050;
- its <u>c</u>Conclusions on the 'Special Report No 27/2021 by the European Court of Auditors: EU <u>s</u>Support to tourism: <u>n</u>Need for a fresh strategic orientation and a better funding approach' of 3 March 2022³.
- 3. UNDERLINES its determination to promote sustainable tourism, <u>taking into</u> consider<u>ationing</u> all the key dimensions of economic, environmental, cultural and social sustainability, <u>among others also</u> in response to <u>among other factors</u>, the climate change and the loss of biodiversity, in accordance with the United Nations 2030 Agenda for Sustainable Development, and its commitment to support tourism that creates sustainable jobs and promotes local culture, products and services.

- 4. ACKNOWLEDGES that tourism significantly contributes to economic development across Europe and can aid withhelp to achieveing the objectives of various EU, national, regional and local policies thanks to its cross-cutting economic and social dimensions and the high ratio of micro, small and medium-sized enterprises operating directly or indirectly along the tourism value chain; IS AWARE that various EU policy areas domains, such as transport, employment or consumer protection, often impact the tourism ecosystem due to its cross-sectoral nature.
- 5. WELCOMES the outcome of the co-creation process of co-creation with Member States and the stakeholders led by the Commission under the Transition Pathway for Tourism⁴ as a follow-up to the commission from the Commission on 'Updating the 2020 New Industrial Strategy: bBuilding a stronger sSingle mMarket for Europe's rRecovery's, which helped to identify possible topics, actions, key actors, conditions and objectives for the green and digital transition of tourism towards a more resilient ecosystem.
- 6. RECOGNISES the work of done by the Commission, Member States and stakeholders to build the basis for the European Agenda for Tourism 2030 through the co-creation process as contained in these conclusions; in this respect context ACKNOWLEDGES that the co-implementation process, as part of the Transition Pathway for Tourism, is a good starting point for strengthening cooperation among tourism stakeholders, the Commission and the Member States.

- 7. STRESSES the importance of promoting a sustainable, innovative and resilient tourism ecosystem, given that:
 - the EU is a top destination for both international visitors and its own residents;
 - in 2019, before the COVID-19 pandemic, the EU tourism ecosystem represented 12.9 %
 of EU Gross Value Added and 15.8 % of employment;
 - with the pandemic, revenues of some sub-sectors dropped by up to 80% of net value₂
 and around 11 million jobs in the EU have already been impacted affected in the tourism ecosystem in 2020;
 - the tourism ecosystem is composed of several economic sectors, which have their own specific sectoral approaches, where over 99 % are micro, small and medium-sized enterprises.

Impact of recent crises on tourism

- 8. UNDERSCORES that the COVID-19 pandemic has had a particularly devastating effect on the tourism ecosystem and **has** led to **a**-significant loss**es** of income, employment and staff.
- 9. EMPHASISES that re-opening and re-starting the tourism ecosystem provides an opportunity to leverage the COVID-19 recovery phase for a green and digital transformation towards a more resilient tourism ecosystem.
- 10. CONDEMNS Russia's unprovoked and unjustified military aggression against Ukraine, and REGRETS its economic, political and humanitarian effects, including its negative impact on tourism, among other sectors, particularly in countries close to Ukraine.
- 11. RECOGNISES that despite the continuing insecurity, the tourism ecosystem has shown solidarity towards refugees from Ukraine, for example by providing temporary accommodation for relocated citizens, supporting their integration or offering them jobs.

- 12. IS CONCERNED that insecurity related to the military aggression of Ukraine, high inflation, rising prices on energy and food products, and disruptions of supply chains, and insecurity related to the military aggression of Ukraine heavily impose heavy burdens on the provision and affordability of travel and hospitality services.
- 13. POINTS OUT that limitations on travel have-a serious effects on the operations and prices of passenger transport across all Member States, including, but not limited to, on-flights and cruises.

Future vision

- 14. STRESSES that the tourism ecosystem is subject to unprecedented conditions that are evolving quickly and affecting its traditional business models.
- 15. EMPHASISES the need to bring more transparency into relations between hosts, online platforms and public bodies, so as to have to make available reliable and available data on who rents out providers of a short-term accommodation rentals; UNDERLINES the importance to enhance transparency in the short-term rental segment and the availability of reliable data, which helps to promote a balanced tourism ecosystem [; in this context, TAKES NOTE of the Commission proposal on a common EU regulatory framework for short-term accommodation rentals].
- 16. UNDERLINES that the digital and green transitions of in the tourism ecosystem, whilst respecting the principles of subsidiarity and proportionality, must be based on collaboration between stakeholders across sectors and different public and private actors at EU, national, regional and local levels.
- 17. TAKES INTO ACCOUNT that the COVID-19 pandemic and the energy crisis have increased recognition of sustainability objectives **both** among EU citizens and globally, and INVITES the Commission, Member States and tourism stakeholders to make use of capitalise on the readiness willingness of many Europeans to change their travel and tourism habits in orderso as to become more sustainable and responsible.

- 18. POINTS OUT that many businesses have proven able to quickly adjust and innovate quickly with respect to their services and products, resources and target markets in exceptional circumstances; CONSIDERS that further increased labour skills and business flexibility can be instruments for a more resilient and sustainable tourism ecosystem.
- 19. POINTS OUT that domestic, <u>cross-border</u> and intra-EU tourism is important to build resilience for destinations, businesses and services.

20. INVITES Member States to:

- a) exchange knowledge and best practices for developing and implementing tourism strategies at various governance levels, taking account of the economic, environmental, cultural and social sustainability of tourism and including the perspectives of visitors as well as local residents, organise awareness-raising activities, among others on such themes as the benefits of the green and digital transformation, demand for sustainable offers, new skills needs and experimenting in tourism, and provide for the protection of local culture, including tangible and intangible cultural heritage;
- b) help to build resilience of in the tourism ecosystem across sectors and different public and private actors;
- c) contribute to the green transition of the tourism ecosystem regarding:
 - i. transport, e.g. by supporting the decarbonisation of mobility, through innovations, new and breakthrough technologies, the development of multimodal travel and <u>by</u> improving increasing the attractiveness of sustainable modes of transport for passengers, with particular regard attention toof the needs of the peripheries, <u>less</u> accessible areas, islands and outermost regions; and by promoting active mobility modes, such as cycling and hiking, and encouraging longer stays;
 - ii. more circular and sustainable operations of <u>by</u> tourism establishments across the
 ecosystem, including attractions, hospitality services, travel agents and tour
 operators;

- iii. the use of relevant green public procurement criteria when <u>in</u> procuring tourism-related services, such as events, hospitality <u>or and</u> travel;
- iv. creat<u>ing</u>e the conditions and incentive<u>s</u> to improve the circularity of tourism services in line with EU-wide and national targets for food waste and waste separation, including reduc<u>ed usetion</u> of single<u>-</u>-use_-plastic;
- v. support<u>ing</u> sustainable tourism with regard to water management, energy efficiency, sanitation capacity and the need to protection of biodiversity;
- d) facilitate the digital transition of <u>in</u> tourism and support the tourism industry and sustainable management of destinations, in particular by:
 - i. improving the availability of comprehensive online information on the tourism offer, including on subjects including sustainability, accessibility and target audiences;
 - ii. in cooperation with the Commission, eontinuing deploying efforts aimed at digitalising travel documents, in accordance with the competences of Member States, and operating digital tools, such as the existing EU Digital COVID Certificate framework, where applicable if needed and relevant:
 - iii. supporting the capacities and digital skills of tourism SMEs to ensure provide innovative tourism products, services and effective communication with their clients;
 - iv. providing the necessary data to the Commission on travel information, including for the Re-open EU platform;
- e) support the development and implementation of innovations in the tourism sector, research and innovation (R&I) projects and multi-disciplinary efforts to develop models and transferable practices for sustainable tourism;

- f) work on improving the availability and volume of statistics and interoperable data_sharing at all levels relevant to the tourism ecosystem;
- g) support the development of the quality of education and skills needed by the tourism workforce, while respecting the principle of subsidiarity, and striving for fairness, equality and social inclusion in tourism jobs, **paying**with attention paid among others to, in particular, the attractiveness of quality employment in the tourism sector and the particular needs of seasonal workers;
- h) promote <u>the</u> accessibility of tourism services to all groups with specific needs;
- i) in their policies, take into account, with regard to solidarity and responsible tourism, the impact of tourism on the quality of life of local communities—with regard to solidarity and responsible tourism;
- j) foster the transition of in the tourism ecosystem, by including via various means of support that comprises, among others, the smart use of EU financial means provided for in the existing programmes and plans adopted within the limits of the EU budget in force, in line with national tourism strategies and the European Agenda for Tourism 2030;
- k) engage in the implementation of the European Tourism Agenda 2030 as set out in these conclusions.

21. INVITES the Commission to:

- a) engage, together with Member States, destinations and other tourism stakeholders, in implementing the European Agenda for Tourism 2030, in particular through:
 - i. the co-implementation process within the Transition Pathway for Tourism;

- ii. the promotion of cross-sectoral cooperation across relevant EU policy domains
 (e.g. transport, regional policy, environment, consumer protection and culture
 and, where relevant, health
) to create a coherent and favourable policy
 environment for tourism;
- iii. <u>the development and promotion</u>, in cooperation with all relevant national and local stakeholders, the development and promotion of governance models for sustainable and diversified management of destinations through <u>the</u> facilitation <u>ofng exchanges of knowledge</u> and best_-practices_-exchange; and
- iv. the establishment of platforms for studies, knowledge development, **the collection and exchange of** best_-practices-collection and exchange, to provide information on existing communities, networks, ongoing projects and their results, topical events, training and funding opportunities, etc.;
- b) provide user-friendly and regularly updated travel information in exceptional situations, including through the Re-open EU platform:
- e) propose a common EU regulatory framework for short-term accommodation rentals in order to enhance transparency in the short-term rental segment and availability of reliable data, which contributes to promoting a balanced tourism ecosystem;
- c.a) review the passenger rights and package travel regulatory framework, to ensure its resilience to extensive travel disruptions, and also assess options for adequate protection of passengers and package travellers against consider the risks of a liquidity crisis;
- d) implement and, where relevantapplicable, further develop, the EU Tourism Dashboard to support the follow-upmonitoring of environmental, digital and socio-economic aspects of tourism;
- ef) support dialogue and cooperation between public authorities and private EU tourism stakeholders at all levels;

- **fg**) support SME digitalisation by collecting and sharing best practices on digital tools and practices for tourism;
- **gh**) identify relevant financing opportunities for Member States and stakeholders through the existing EU budget and other sources to work towards the objectives recognised in this Agenda, including through the regular updatinge of the 'Guide on EU funding for tourism' and other means;
- <u>h</u>i) support awareness-raising activities for citizens and tourism stakeholders on the benefits of the green and digital transformation, consumers' demand for sustainable offers, <u>the</u> <u>development of</u> new skills, <u>development and</u>-innovative pilot projects in tourism, and <u>design and</u> test the use of environmental footprint methodologies for the tourism ecosystem;
- **i**j) support capacity-building programmes and various means of assistance for SMEs to engage in environmentally friendly practices and schemes;
- jk) cooperate with Member States to ensure the provision that consolidated of tourism statistics data are provided, based on harmonised data, that which include elements and indicators on relating to economic, social, cultural and environmental sustainability, in cooperation with European Statistical System actors;
- **<u>k</u>**1) support Member States and tourism stakeholders in implementing interoperable datasharing practices;
- lm) support Member States and relevant stakeholders in tourism with its expertise and experience and follow up on the actions supporting the European Agenda for Tourism 2030 in the framework of the Transition Pathway for Tourism through annual feedback of from experts from Member State experts in the Tourism Advisory Committee (TAC);
- <u>mn</u>) follow up to-<u>on</u> the implementation of the European Tourism Agenda 2030 and report to the Council every three years.

22. INVITES tourism stakeholders to:

- a) engage in the implementation of this European Tourism Agenda 2030, in cooperation with the Commission and the Member States, <u>raising awareness to their partners and customers</u> and contribute with their expertise and experience to the co-implementation of the tourism transition <u>while disseminating the knowledge and outcomes achieved</u>;
- b) {where relevant, commit with concrete pledges, on <u>a</u> voluntary basis, to the implementation of the Tourism Transition Pathway actions as their support for the Multi-annual EU Work Plan <u>of the European Agenda for Tourism 2030 as presented in the Annex</u>}.
