**Subject: Appointment of Mr. Pritt Potisepp as a Member of the ESGAB for a second term**

Dear Minister Stanjura,

In accordance with Decision No 2008/235/EC of the European Parliament and of the Council of 11 March 2008 establishing the European Statistical Governance Advisory Board (hereafter 'the Decision'), the Council shall appoint three Members after consulting the Commission. The Council appointed Mr. Pritt Potisepp for a period of three years, starting on 23 December 2019 (Decision of 19 December 2019 (2019/C 428/05)).

The term of Mr. Potisepp, Member appointed by the Council, will come to an end on 22 December 2022. In accordance with Art. 3.4 of the Decision, Mr. Potisepp is eligible for a second term and has expressed the willingness to be renewed in the office. His CV is attached to this letter.
