Subject:	Transfer of appropriations No DEC 23/2022 within Section III - Commission - of the general budget for 2022

---

1. On 21 October 2022, the Commission submitted to the Council proposal for transfer of appropriations No DEC 23/2022, in accordance with Article 31(1) of the Financial Regulation<sup>1</sup>.

The purpose of this proposal is to transfer an amount of EUR 3.96 million in commitment appropriations from Article 30 02 02 (*Differentiated appropriations*) to Article 08 05 01 (*Establishing a governance framework for fishing activities carried out by Union fishing vessels in third country waters*), as recorded in document 13885/22.

2. The purpose of this transfer is to cover:
  - the financial obligations resulting from the signing and conclusion of a Protocol implementing the Sustainable Fisheries Partnership Agreement (SFPA) between the EU and the Republic of Mauritius (EUR 0.72 million).
  - additional catches related to the financial year 2022 as set out in the relevant SFPAs and Protocols for the Government of Greenland and the Democratic Republic of Sao Tomé and Príncipe (EUR 3.2 million in c/a).
3. The Budget Committee examined the proposal for a transfer at its meeting on 3 November 2022.
4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
  - the proposed transfer of appropriations, as set out in 13885/22; and
  - the draft letter in the ANNEX to this note.
