Dear President-in-Office,

Further to my letter of 11 July 2019 on the unfinished business of the 8th parliamentary term, I should like to inform you that, at its meeting on 16 October 2019, the Conference of Presidents took a decision on reasoned requests from parliamentary committees to resume or continue the consideration of files under the ordinary legislative procedure or under other procedures.

Consequently, the decision on unfinished business from the 8th parliamentary term is as follows: one file has lapsed, namely the proposal on 'Strengthening fiscal responsibility and the medium-term budgetary orientation in the Member States' (CNS 2017/0335); there are 12 requests for withdrawal; and there have not been any requests for renewed referral or re-consultation.

Please find the details in the following annexes:

- for files under the ordinary legislative procedure
 - a list of files on which Parliament had not adopted a first reading position and on which work should resume (Annex I, part A); and
 - a list of files on which Parliament had already adopted a first reading position and which are awaiting Council's first reading position (Annex I, part B);
