- 1. <u>The General Secretariat of the Council</u> has been informed of the resignation of Ms Ruta PORNIECE as member of the above Committee in the trade unions' representatives category (for Latvia).
- 2. Under Article 75 of Regulation (EC) 883/2004 of 29 April 2004¹ which sets up the Advisory Committee for the Coordination of Social Security Systems, members and alternate members are appointed by the Council, whereas by the Council Decision of 13 October 2015², the appointments are valid for a period of five years.
