Nomination of members and alternate members of the European Committee of the Regions

Government decision

In accordance with Article 305 of the Treaty on the Functioning of the European Union, the Government hereby nominates Marta Aguirre (V), Sigtuna kommun (municipality of Sigtuna), Pär Löfstrand (L), Östersunds kommun (municipality of Östersund) and Tomas Riste (S), Karlstads kommun (municipality of Karlstad), as members, and Mätta Ivarsson (MP), Region Skåne (region of Skåne) and Kristoffer Tamsons (M), Region Stockholm (region of Stockholm), as alternate members of the European Committee of the Regions until 25 January 2025 (see *Annex*).

Background

Samuel Gonzalez Westling (V), Ulrika Landergren (L), Emma Nohrén (MP) and Alexander Wendt (M) have resigned from their positions in the European Committee of the Regions. Tomas Riste (S) has not retained his mandate in the regionfullmäktige (regional council), which served as the basis for his role in the Committee of the Regions, and has therefore resigned from his position. However, he has a new mandate in the kommunfullmäktige (municipal council).

Sveriges Kommuner och Regioner (the Swedish Association of Local Authorities and Regions) has proposed that the following persons be nominated as members and alternate members of the Committee of the Regions: Marta Aguirre (V) as a member in place of Samuel Gonzalez Westling (V), Pär Löfstrand (L) as a member in place of Ulrika Landergren (L), Tomas Riste (S) as a member on the basis of a new mandate, Mätta Ivarsson (MP) as an alternate member in place of Emma Nohrén (MP) and Kristoffer Tamsons (M) as an alternate member in place of Alexander Wendt (M).
