## ANNEX

Position to be taken by the Member States which are members of the Commission on Narcotic Drugs, acting jointly, in the interest of the Union during the sixty-six session of the Commission on Narcotic Drugs scheduled from 13 to 17 March 2023 regarding changes in the scope of control of substances:

- (1) ADB-BUTINACA is to be included in Schedule II of the Convention on Psychotropic Substances.
- (2) Adinazolam is to be included in the Schedule IV of the Convention on Psychotropic Substances.
- (3) Bromazolam is to be included in the Schedule IV of the Convention on Psychotropic Substances.
- (4) Protonitazene is to be included in Schedule I of the Convention on Narcotic Drugs.
- (5) Etazene is to be included in Schedule I of the Convention on Narcotic Drugs.
- (6) Etonitazepyne is to be included in Schedule I of the Convention on Narcotic Drugs.
- (7) 2-methyl-AP-237 is to be included in Schedule I of the Convention on Narcotic Drugs.
- (8) Alpha-PiHP is to be included in the Schedule II of the Convention on Psychotropic Substances.
- (9) 3-MMC is to be included in the Schedule II of the Convention on Psychotropic Substances.
