	Appointment of Ms Katja GERSTMANN, alternate member for Austria, in place of Ms Eva-Maria BURGER, who has resigned

- 1. The General Secretariat of the Council has been informed of the resignation of Ms Eva-Maria BURGER as alternate member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Austria).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006<sup>1</sup> provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

Having regard to Regulation (EC) No 1922/2006 of 20 December 2006 establishing the European Institute for Gender Equality<sup>2</sup>, and in particular Article 10 thereof,

Whereas:

- (1) By its Decision of 27 May 2019<sup>3</sup> the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2022.
- (2) An alternate member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Eva-Maria BURGER.
- (3) The Government of Austria has submitted a nomination for the vacant seat,
