

The Mission of Switzerland to the European Union presents its compliments to the General Secretariat of the Council of the European Union and herewith confirms receipt of the notification of the Council dated 9 December 2022, issued in accordance with Article 7, paragraph 2 a, first sentence of the agreement between the European Union, the European Community and the Swiss Confederation on the Swiss Confederation's association with the implementation, application and development of the Schengen acquis (hereinafter referred to as « association agreement ») signed in Luxembourg on 26 October 2004. The content of the notification is as follows:

In accordance with the first sentence of Article 7(2)(a) in conjunction with Article 14(1) of the Agreement associating Switzerland to the Schengen acquis, Switzerland is herewith notified of the adoption of the following act:

Decision of the European Parliament and of the Council on the non-acceptance of travel documents of the Russian Federation issued in Ukraine and Georgia

Council Document: PE-CONS 57/22

Date of adoption: 8 December 2022»

In accordance with Article 7, paragraph 2 a, second sentence of the association agreement, the Mission of Switzerland herewith notifies the General Secretariat of the Council that Switzerland accepts the content of the enclosed appendix to the notification of the Council, which forms an integral part of this reply.

In accordance with Article 7, paragraph 3 of the association agreement, the notification of the Council dated 9 December 2022 and this reply give rise to rights and obligations between Switzerland and the European Union and thus constitute an agreement between Switzerland and the European Union.

This agreement shall enter into force on the date of this reply. It may be terminated in accordance with the provisions of Articles 7 and 17 of the association agreement.
