Thank you for your request for access to documents of the Council of the European Union.¹

In response to your request, let us confirm that a proposal was submitted to the Terrorism Working party (TWP) by Germany and France in November 2022 indeed. Presentations given by EUROPOL and German delegation in TWP on 14-15 November 2022 are contained in Council document WK 15927/22. The presentation given by the IntCen was not published.

I regret to inform you that access to the above-mentioned documents cannot be given for the reasons set out below.

The objective of the documents is to serve as a basis for discussion with experts in the area of potential terrorist threat. The documents are still undergoing examination in the Council. For the Council to reach an agreement, its Member States held consultations and exploratory talks. To reveal the content of such talks before a common position has been reached would interfere with the negotiations and would jeopardise the conclusion of an agreement within the Council.

The disclosure of the texts at a moment when the appropriate balance of the various interests involved has not yet been achieved within the Council's preparatory bodies would reduce the flexibility for delegations to formulate and reconsider their positions in the light of the arguments exchange in the debate. This would seriously affect the chances of finding a convergence in delegations' positions.

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

Disclosure of the documents at this early stage would therefore seriously undermine the decision-making process of the Council. As a consequence, the General Secretariat has to refuse access to the documents.²

Having examined the context in which the documents were drafted, on balance the General Secretariat could not identify any evidence suggesting an overriding public interest in their disclosure.

We have also looked into the possibility of releasing parts of the documents.³ However, as the information contained in the documents forms an inseparable whole, the General Secretariat is unable to give partial access.

Moreover, the release of the information contained in the documents would jeopardise the public security by revealing specific assessment and sensitive information based upon the available findings and taking into account the ongoing work in this area at EU level and recent developments.

Therefore, the General Secretariat is of the opinion that the disclosure of the documents would undermine the protection of the public interest as regards public security. As a consequence, the General Secretariat has to refuse access to the documents.⁴

Pursuant to Article 7(2) of Regulation (EC) No 1049/2001, you may ask the Council to review this decision within 15 working days of receiving this reply. Should you see the need for such a review, you are invited to indicate the reasons thereof.
