In accordance with the first subparagraph of Article 12(2)(d) of Regulation (EU, Euratom) No 2018/1046 and Article 26 of Regulation (EU) No 1306/2013, non-committed European Agricultural Guarantee Fund (EAGF) appropriations under shared management may be carried over to the following financial year, respecting the limit of 2 % of the initial voted appropriations or the amount of the adjustment of direct payments for EAGF financial discipline.

Article 17(4) of Regulation (EU) 2021/2116 provides that reimbursement shall apply only to final beneficiaries in those Member States where financial discipline applied in the preceding financial year. Commission Implementing Regulation (EU) 2022/2344 sets the amounts that each Member State must reimburse to farmers and determines that expenditure in relation to this reimbursement shall only be eligible for Union financing if the amounts have been paid to the beneficiaries before 16 October 2023.

The amount of EUR 485 247 362 from item 08 02 05 12 will be carried over to 2023 and made available to the Member States for the reimbursement.

However, all preparatory steps for the adoption of those programmes had been concluded, including the closure of the inter-service consultation without blocking comments. Therefore, in accordance with Article 12(2)(a) of Regulation (EU, Euratom) 2018/1046, the amount of EUR 151 112 411 in commitment appropriations corresponding to the 2022 allocation of the relevant programmes is carried over to 2023.

Therefore, in accordance with Article 12(2)(a) of Regulation (EU, Euratom) 2018/1046, the amount of EUR 8 054 788 in commitment appropriations, corresponding to the 2022 allocation of the programme, is carried over to 2023.

Therefore, in accordance with Article 12(2)(a) of Regulation (EU, Euratom) 2018/1046, the amount of EUR 7 783 246 in commitment appropriations, corresponding to the 2022 allocation of the programme, is carried over to 2023.

All preparatory steps for the adoption of this programme, including the closure of the inter-service consultation, were finalised in 2022. However, the adoption of the programme could not be concluded before 31 December 2022. Therefore, in accordance with Article 12(2)(a) of Regulation (EU, Euratom) 2018/1046, the amount of EUR 3 442 115 in commitment appropriations, corresponding to the 2022 allocation of the programme, is carried over to 2023.

According to Decision (EU) 2023/68 of the European Parliament and of the Council of 14 December 2022, an amount of EUR 700 348 683 was mobilised under the European Union Solidarity Fund to provide assistance to Germany and Belgium in relation to the natural disasters that took place in summer 2021. The Commission could not disburse that amount because the two beneficiary Member States had not provided the information required for the implementation of the financial contribution from the Fund before the end of 2022. The unused commitment appropriations of EUR 700 348 683 are carried over automatically to 2023, in accordance with Article 12(4)(a) of Regulation (EU, Euratom) 2018/1046. Therefore, the corresponding amount in payment appropriations is needed in 2023 to honour the financial support to Germany and Belgium. Since there are no corresponding payment appropriations available on the relevant budget line for 2023, in accordance with the first subparagraph of Article 12(2)(c) of Regulation (EU, Euratom) 2018/1046, the amount of EUR 700 348 683 in payment appropriations is carried over to 2023.
