- 1. By letter of 31 January 2023¹, the European Court of Auditors (ECA) informed the Council of the end of the term of office of the following Members of the ECA, during the first half of 2024:
 - end of the term of office on 29 February 2024:

In the same letter, the ECA also informed the Council that the term of office of the post of the Portuguese member, vacant since 30 June 2021, would end on 29 February 2024.

- 2. Article 286(1) and (2), first subparagraph, TFEU states that:
 - "1. The Members of the Court of Auditors shall be chosen from among persons who belong or have belonged in their respective States to external audit bodies or who are especially qualified for this office. Their independence must be beyond doubt.
 - 2. The Members of the Court of Auditors shall be appointed for a term of six years. The Council, after consulting the European Parliament, shall adopt the list of Members drawn up in accordance with the proposals made by each Member State. The term of office of the Members of the Court of Auditors shall be renewable".
- 3. In order to ensure the continuity of ECA's work, the new Members of the ECA should be appointed no later than the end of January 2024.
- 4. The Member States concerned should therefore send their proposals to the General Secretariat of the Council no later than **15 September 2023**. To that effect, the General Secretariat of the Council will send a letter to the Member States concerned.
- 5. It is therefore suggested that the Permanent Representatives Committee approve the wording of the reply letter to the Secretary-General of the ECA, as set out in the Annex to this note, in accordance with Article 19(7)(k) of the Council's Rules of Procedure.

Sir,

In reply to your letter of 31 January 2023 concerning eight posts of Members of the European Court of Auditors (ECA) whose terms of office will expire in February and April 2024, I have the pleasure to inform you that the General Secretariat of the Council will request the Member States concerned to put forward their nominations for Members of the ECA no later than 15 September 2023.

In order to ensure the continuity of ECA's work, the Council Decision appointing the Members of the Court should be adopted no later than the end of January 2024. To that end, the procedure for the appointment of the Members should start sufficiently early to allow for the timely consultation of the European Parliament.
