Subject: Advisory Committee for the Coordination of Social Security Systems
Appointment of Ms Christina JANZON, alternate member for Sweden, in
place of Ms Kristin PAULSSON, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Kristin PAULSSON as alternate member of the above Committee in the governments' representatives category (for Sweden).
2. Under Article 75 of Regulation (EC) 883/2004 of 29 April 2004¹ which sets up the Advisory Committee for the Coordination of Social Security Systems, members and alternate members are appointed by the Council, whereas by the Council Decision of 21 September 2020², the appointments are valid for a period of five years.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 883/2004 of the European Parliament and of the Council of 29 April 2004 on the coordination of social security systems³, and in particular Article 75 thereof,

Whereas:

- (1) In its Decisions of 21 September 2020⁴ and 19 October 2021⁵, the Council appointed the members and alternate members of the Advisory Committee for the Coordination of Social Security Systems for the period ending on 19 October 2025.
- (2) A seat as alternate member in the governments' representatives category has fallen vacant as a result of the resignation of Ms Kristin PAULSSON.
- (3) The government of Sweden has nominated a candidate for the vacant seat,

HAS ADOPTED THIS DECISION:
