Joint political statement by the European Parliament and the Council of the European Union on the financing of the Union Secure Connectivity Programme for the period 2023-2027

“The European Parliament and the Council agree, without prejudice to the prerogatives of the budgetary authority in the framework of the annual budgetary procedure, that the financing of the Union Secure Connectivity Programme for the period 2023-2027 will indicatively be covered in the years 2023-2027 as follows:

- EUR 200 million from the unallocated margins from Heading 1 and Heading 5;
- EUR 1,450 million from contributions from Heading 1, Heading 5 and Heading 6.”

Joint political statement by the European Parliament, the European Commission and the Council of the European Union on the re-use of decommitted funds in Horizon Europe

“In the Joint Declaration on the re-use of decommitted funds in relation to the research programme the European Parliament, the Council and the Commission agreed to make available again to the benefit of the research programme commitment appropriations, corresponding to the amount up to EUR 0,5 billion (in 2018 prices) in the period 2021-2027 of decommitments, which results from total or partial non-implementation of projects belonging to the ‘Horizon Europe’ Framework Programme or its predecessor ‘Horizon 2020’, as provided for in Article 15(3) of the Financial Regulation.

In the statement on Regulation (EU) 2021/695 of the European Parliament and of the Council of 28 April 2021 establishing Horizon Europe – the Framework Programme for Research and Innovation, laying down its rules for participation and dissemination, and repealing Regulations (EU) No 1290/2013 and (EU) No 1291/2013(1), the European Parliament, the Council and the Commission agreed on an indicative distribution of that amount that will be up to EUR 300 000 000 in constant 2018 prices for the cluster ‘Digital, Industry and Space’ in particular for quantum research.

Without prejudice to the powers of the budgetary authority in the framework of the annual budgetary procedure and to the Commission’s powers to implement the budget, the European Parliament, the Council and the Commission agree that, within the cluster on ‘Digital, Industry and Space’ of Horizon Europe, an indicative amount of EUR 200 000 000 in constant 2018 prices will be allocated to secure connectivity research activities.”

Statement by the Commission

“The Commission proposed the Union Secure Connectivity Programme on 15 February 2022. The Russian invasion of Ukraine one week later and the events since have shown the need for enhanced secure connectivity in the EU and for an accelerated implementation of the programme. Therefore, pending its formal adoption, the Commission has brought forward the implementation of part of the activities linked to secure connectivity of a part of the new programme that could be sustained under the existing legal acts, and which requires an intensive development phase, in particular under the Connecting Europe Facility (CEF) and the Digital Europe Programme (DIGITAL). Several calls under the work programmes 2021 and 2022 of the DIGITAL and the digital strand of CEF include actions that will later be taken over by the Union Secure Connectivity Programme under the Quantum Communication infrastructure objective.

Grants to beneficiaries will start being signed as of the end of 2022 and in 2023. The total amount already allocated to Quantum Communication activities under DIGITAL and CEF is EUR 260 million in 2021 and 2022. Since an amount of EUR 260 million from DIGITAL and CEF has already been implemented, it will be deducted from the financial envelope of the Union Secure Connectivity Programme for the period from 1 January 2023 to 31 December 2027. Thus, the overall amount devoted to activities related to secure connectivity during this MFF remains unchanged at EUR 2.4 billion. Only the distribution between to be earmarked amounts under CEF and DIGITAL and the budget lines of the new programme will vary.”

Statement by Greece

“Statement of the Hellenic Republic on the Regulation establishing the Union Secure Connectivity Programme for the period 2023-2027

Greece was from the very beginning a strong supporter of the Commission's secure connectivity initiative and welcomes the swift completion of the Regulation establishing the Union Secure Connectivity Programme for the period 2023-2027 and hopefully beyond.

Connectivity is a core political priority for Greece and this has been reflected in its RRF programme. Blending space and terrestrial infrastructure can provide connectivity in a secure and resilient manner, which is necessary for our governments, economy and society. Greece has its own GOVSATOM system ("GreeCom"), participates actively in EU programmes such as Galileo, Copernicus and EuroQCI, is one of the members of the SST Consortium and has launched a national microsatellite project aiming to strengthen and maximise the engagement of all space actors, utilise and expand its infrastructure and respond to the needs for secure connectivity.

In this spirit, Greece underlines the need to ensure a balanced distribution of the Union Secure Connectivity Programme's capacities among the Member States and stresses the absolute necessity to guarantee the interoperability and the complementarity of the Union Programme with the national relevant activities, capacities and infrastructure during the preparation, the development, the implementation and the running of the Programme.”

Statement by Croatia

“The Republic of Croatia expresses its full support for the adoption of the Regulation of the European Parliament and of the Council establishing the Union Secure Connectivity Programme for the period 2023-2027.

However, the Republic of Croatia reiterates its discontent with the current Croatian linguistic version of the proposal for the Regulation, i.e. with the Croatian equivalent of the English term “cyber” and its derivatives into the Croatian language , an issue which we have continuously raised on several levels within the Council during the last few years.

The current Croatian version of the proposal for the Regulation uses terminology that is non-existent in Croatian cyber legislation and professional use, thus creating confusion and undermining legal certainty, coherence and clarity.

The Republic of Croatia reiterates its position that the terminology used by the EU institutions should be aligned with already existing national legal terminology in order to ensure legal certainty.

The Republic of Croatia remains committed to promoting secure communications with a new constellation of satellites and continues to support the adoption of the Regulation.”

Statement by Poland

“Poland firmly opposes the adoption of this legislative act.

It is not in favour of the new fees and burdens being passed on to citizens, e.g. by increasing the cost of access to fuels. Any additional costs resulting from the new burdens should be borne by manufacturers and not passed on to citizens. EU legislation should provide an incentive for car manufacturers to offer zero-emission vehicles at the lowest possible cost to citizens. It should also take into account the differing circumstances of the individual Member States so as to avoid exacerbating social stratification, poverty or exclusion.

Trends aimed at reducing vehicle emissions should take account of the market potential in terms of both the technological particularities of vehicle or vehicle equipment manufacturers and the economic aspects, with due regard for the financial capacity of the country's citizens. Furthermore, Poland cannot accept the inclusion of exemptions for manufacturers of certain luxury brands; this is incompatible with the general principle that emissions should be reduced by all sectors in a manner which is socially fair. In times of crisis, derogations should be directed at the poorest citizens rather than at luxury car manufacturers. Poland therefore expresses its opposition to this legislative act.”

Statement by Italy

“Italy shares and is fully committed to the goal of decarbonizing the road transport sector, as the reduction of the sector's CO2 emissions, notably those deriving from passenger cars and light duty vehicles, is essential in order to achieve the Union's climate objectives.

We believe that, in the road transport sector, the decarbonization has to be pursued in adherence to the principles of an economically viable and socially fair transition towards zero emissions and of technological neutrality.

We certainly support the electrification of light vehicles. We do not believe, however, that it should represent, in the transition phase, the only pathway to reach zero emissions.

Electrification requires significant changes in the overall automotive sector that have to be planned and guided with due attention, in order to avoid undesired economic, industrial and social effects. Cars with thermic engines are owned by low-income citizens and will remain in circulation beyond 2035. The success of electric cars will very much depend on how they will become affordable for those citizens.

Meanwhile, technological neutrality will allow Member States to avail themselves of all solutions at their disposal for decarbonizing the transport sector, according to their national circumstances and starting points. The use of renewable fuels, compatible with thermic engines, will ensure an immediate emissions reduction without requesting disproportionate economic sacrifices to citizens. Forcing electrification may, to the contrary, bear the risk of a

lack of market acceptance, that can damage cars and vans manufactures. It would also prevent the technological development of hybrid engines with very low environmental impact.

From an industrial point of view, an increased demand of renewable fuels will offer an important opportunity for conversion to the petrochemicals sector.

By establishing a 100% emissions reduction target in 2035 and by not envisaging any incentive for the use renewable fuels, the proposed Regulation is not in line with the technological neutrality principle. Therefore, Italy cannot support it.

We recall that the achievement of a 100% emissions reduction target depends upon several conditions, including:

- the development of an electric engines and batteries value chain in the Union;
- a sustainable and diversified supply of the required raw materials;
- adequate recharging and refueling infrastructures;
- an improvement of the electricity network, so that it can cope with the increased demand;
- an adaptation of the overall automotive sector, also with through the provision of the necessary skills;
- the acceptance by the market of the new vehicles, which should become available at an affordable price, particularly for families and the most vulnerable consumers.

If such conditions, whose fulfilment is not depending on the implementation of Regulation 2019/631 alone and will require significant investments and compensation measures, are not met, the impact of the target would be severe, in economic, social and environmental terms, as well as for the strategic autonomy of the Union.

We note, in this regard, that so far, the approach chosen by the Union for the automotive sector is prevalently regulatory, while US (with IRA) and China have also adopted stimulus plans.

We therefore believe that the Commission should:

- support, with all the available means, legislative and financial, the transition of the automotive sector, particularly SMEs;

- follow up on the provision on registering after 2035 vehicles running exclusively on CO2 neutral fuels (preamble 11);
- make a proposal for including in the Regulation mechanisms accounting for the benefits, in terms of CO2 emissions reduction, of renewable fuels.”

Joint statement by Hungary and Poland

“In accordance with the Treaties, the information rights of the EP are not on par with those of the Council in the context of the implementation of international agreements. The extended information provision by the Commission to the European Parliament under this regulation is justified by the special nature of the Withdrawal Agreement and the Trade and Cooperation Agreement, i.e. that these have been concluded with a former EU member state.

Accordingly, nothing in this Regulation can be regarded as an expansive interpretation of Article 218 (10) TFEU, which lays down the prerogative of the European Parliament to be informed in the course of the negotiation and conclusion of international agreements. Consequently, we deem that information to be provided to the European Parliament in the context of the implementation of the Agreements in question, as prescribed in recital 5 (c), goes beyond respective institutional powers under the Treaties, does not set a general precedent and should not be repeated in future implementing regulations of international agreements concluded by the EU.”

“Romania recalls that the adoption by the Council of the Regulation of the European Parliament and of the Council amending Regulation (EU) 2018/1806 listing the third countries whose nationals must be in possession of visas when crossing the external borders and those whose nationals are exempt from that requirement (Kosovo*) is without prejudice to its position on the status of Kosovo*.

In line with the above, Romania underlines that, with reference to paragraph 5 of the Preamble of the Regulation, is not bound to conclude a readmission agreement with Kosovo*.”

“The Commission will not oppose the adoption of the revised text of the Union position for the scheduling of new psychoactive substances at the next meeting of the United Nations Commission on Narcotic Drugs (CND), but wishes to make the following statement:

The Commission reiterates its position that the decisions concerned by this proposal are adopted by qualified majority and are a matter of exclusive Union competence because Union law, in this case in the area of drug control, will be directly and automatically affected by the scheduling decisions of the United Nations Commission on Narcotic Drugs. The Commission underlines that this position refers to international scheduling decisions under the 1961 UN Convention on Narcotic Drugs and the 1971 UN Convention on Psychotropic Substances and not to drugs policy in general.”
