NOTE VERBALE

The Mission of the Kingdom of Norway to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honor to refer to the Agreement between the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen acquis, signed on 18 May 1999.

The Mission of the Kingdom of Norway to the European Union refers to the adoption of the following acts by the European Parliament and the Council of the European Union:

- *Regulation (EU) 2021/954 of the European Parliament and of the Council of 14 June 2021 on a framework for the issuance, verification and acceptance of interoperable COVID-19 vaccination, test and recovery certificates (EU Digital COVID Certificate) with regard to third-country nationals legally staying or residing in the territories of Member States during the COVID-19 pandemic*
- *Regulation (EU) 2022/1035 of the European Parliament and of the Council of 29 June 2022 amending Regulation (EU) 2021/954 on a framework for the issuance, verification and acceptance of interoperable COVID-19 vaccination, test and recovery certificates (EU Digital COVID Certificate) with regard to third-country nationals legally staying or residing in the territories of Member States during the COVID-19 pandemic*

In accordance with Article 8 paragraph 2 (a) of the Agreement, the Mission of the Kingdom of Norway to the European Union hereby notifies, on behalf of the Government of Norway, that Norway has accepted the content of the said regulations.
