#### 1. Introduction

The Oireachtas Joint Committee on Agriculture, Food and the Marine ("the Committee") considers Proposal for a REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL on the sustainable use of plant protection products and amending Regulation (EU) 2021/2115 to be significantly important to Ireland and the EU.

## 2. Scrutiny by the Committee

The Committee first considered the proposal at a private meeting on 2 November 2022. Following this meeting, the Committee agreed to invite Officials from Ireland's Department of Agriculture, Food and the Marine (DAFM) to brief the Committee further on this proposal. This meeting was held on 23 November 2022 and a transcript of the meeting can be found <a href="https://example.com/here">here.</a>. Having considered its discussion with Officials from DAFM, the Committee considered the proposal again at a private meeting on 16 January 2023. It was agreed by the Committee at this meeting to write a Political Contribution on this proposal.

#### 3. Decision of the Committee

On 21 March 2023 the Committee agreed to forward a copy of this Political Contribution to Charlie McConalogue T.D., Minister for Agriculture, Food and the Marine, Ursula von der Leyen, President of the European Commission, Roberta Metsola MEP, President of the European Parliament, and Charles Michel, President of the European Council.

The Committee further agreed that, in the interests of inter-parliamentary cooperation on EU matters, a copy of this report be forwarded to the appropriate Committee in the National Parliament of each EU Member State and to Ireland's MEPs.

## 4. Opinion of the Committee

The Committee agrees with the goal of the proposal of achieving a safe and affordable production of food in line with sustainability principles and safeguarding eco-systems, however food security of the European Union and the viability of income of farmers must also be guaranteed.

Having considered the proposal in detail, the Committee makes the following observations:

- Articles 4 & 5 relate to that target of 50% reduction in the use and risk of chemical
  plant protection products by 2030. The Committee is concerned without a detailed
  impact assessment Member States are starting from different positions and
  flexibility in setting national targets is required to accommodate the individual
  circumstances of Member States.
- The Committee notes that Article 15 will require Member States to set detailed cropspecific rules. The Committee is concerned that the level of detail for crop-specific rules that are required to be legislated for at national level and updated as it arises may have a large administrative burden on Member States and may go beyond what is required to achieve this proposal's goal.

- The proposal states that placing biological plant protection products on the market
  will give farmers more alternative options for sustainable crop protection. In
  particular Article 15.6(c) references low-risk plant protection products or alternatives
  to chemical plant protection products which are effective against the harmful
  organisms to provide farmers with tools to substitute chemical plant protection
  products. The Committee supports research and development of alternative
  substances, and it is their view that they should be quickly and widely available to
  aid Member States to reach their 2030 target.
- The Committee believes that the definition of 'sensitive area' provided under
  Article 3 (16) of the proposal is too broad as it covers Natura 2000 sites and
  designated areas. The Committee is concerned of the use of this definition within
  Article 18 of the proposal which details the use of plant protection products in
  sensitive areas. In its current form the proposal may have a negative implication on
  Ireland as it may cover a significant amount of farmland which would fall under
  Natura 2000 sites and designated areas. The Committee is concerned that under this
  definition the provision of use of pesticides would no longer be permitted in Natura
  2000 sites and designated areas which are currently used for agricultural activities
  such as livestock grazing.

It is the opinion of the Committee that the current form of the proposal will have negative implications for both Ireland and other Member States. The Committee requests that the definition of 'sensitive area' is reconsidered to take into account Natura 2000 sites and designated areas which are used for agricultural use and may require the provision of use of pesticides. The Committee also believes that as CAP 2023 -2027 has commenced and Members States CAP Strategic Plans have been approved without this proposal being taken into account, additional EU funding should be provided to compensate farmers to the cover costs that will arise from the requirements of this proposal. The Committee requests a response on the above concerns raised by 16 May 2023.
