The Mission of the Kingdom of Norway to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honor to refer to the Agreement between the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the latter's association with the implementation, application and development of the Schengen acquis, signed on 18 May 1999.

The Mission of the Kingdom of Norway to the European Union refers to the adoption of the following acts by the Council of the European Union:

- *Regulation (EU) 2017/2225 of the European Parliament and of the Council of 30 November 2017 amending Regulation (EU) 2016/399 as regards the use of the Entry/Exit System*
- *Regulation (EU) 2017/2226 of the European Parliament and of the Council of 30 November 2017 establishing an Entry/Exit System (EES) to register entry and exit data and refusal of entry data of third-country nationals crossing the external borders of the Member States and determining the conditions for access to the EES for law enforcement purposes, and amending the Convention implementing the Schengen Agreement and Regulations (EC) No 767/2008 and (EU) No 1077/2011*
- *Regulation (EU) 2018/1240 of the European Parliament and of the Council of 12 September 2018 establishing a European Travel Information and Authorisation System (ETIAS) and amending Regulations (EU) No 1077/2011, (EU) No 515/2014, (EU) 2016/399, (EU) 2016/1624 and (EU) 2017/2226*

In accordance with Article 8 paragraph 2 (a) of the Agreement, the Mission of the Kingdom of Norway to the European Union hereby notifies, on behalf of the Government of Norway, that Norway has accepted the content of the said regulations.
