Subject: Management Board of the European Institute for Gender Equality:
Appointment of Mr Pawel Kosmulski, alternate member for Poland, in place
of Ms Karolina Michalczyk, who has resigned

1. The General Secretariat of the Council has been informed of the resignation of Ms Karolina MICHALCZYK, as alternate member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Poland).
2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006¹ provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years. The appointed members and alternate members represent eighteen Member States in the order of the rotating Presidencies, one member and one alternate member being nominated by each Member State.
3. By its Decision of 24 May 2022, the Council appointed the members and alternate members for the period ending on 31 May 2025.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EC) No 1922/2006 of 20 December 2006 establishing the European Institute for Gender Equality², and in particular Article 10 thereof,

Whereas:

- (1) By its Decision of 24 May 2022³ the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2025.
- (2) An alternate member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Karolina Michalczyk.
- (3) The Government of Poland has submitted a nomination for the vacant seat,

HAS ADOPTED THIS DECISION:
