#### 6. Organisation of future work

<u>The Presidency</u> informed the SCA on the "Agriculture and Fisheries" Council meeting on 25 April and the next SCA meeting on 8 May 2023.

As regards the "Agriculture and Fisheries" Council meeting on 25 April:

- <u>The SCA</u> unanimously agreed to the addition of a discussion item on the Market situation to the agenda.
- Three market-related items under "any other business" were requested, which will be taken jointly with the newly added discussion item:
  - One item on the "Necessary actions that need to be taken to counteract the market disturbances in the EU Member States most impacted by increased imports of agri-food products from Ukraine", requested by the Polish delegation on behalf of the delegations concerned;
  - One item requested by <u>the Slovak delegation</u> on a "proposal to mitigate the impact of imports from Ukraine on EU markets"; and
  - One item jointly requested by <u>the Lithuanian and Latvian delegations</u> on the "continuing crisis in the dairy sector".
- In addition, the Slovenian delegation requested an item under "any other business" on
  the "Commission's report on the findings of the EU coordinated action 'From the hives'
  and its relevance for the revision of the Council Directive on honey (2001/110/EC)".

  The SCA subsequently agreed that this item would be held in public session in
  accordance with article 8(2) of the rules of procedure of the Council.
