The European Union and Kosovo,

Reaffirming the high importance they attach to the extension of the trans-European transport network to Kosovo as part of the Enlargement Policy,

Mindful that the indicative maps of trans-European transport network extended to Kosovo:

- aim to ensure the coherence between the trans-European transport network of the Union and the transport network of Kosovo;
- aim to promote adequate planning and development of sustainable and resourceefficient transport connectivity between the Union and Kosovo;
- facilitate the identification of common infrastructure priorities between the Union and Kosovo;
- aim to facilitate the development of the existing transport network,

came to the understanding that the adapted indicative maps of the transport infrastructure network in Kosovo, annexed to the present high-level understanding, is acceptable to both sides.

This high-level understanding does not, nor is it intended to create rights or obligations under domestic or international law
