## **'I/A' ITEM NOTE**

Subject:	COUNCIL DECISION authorising the opening of negotiations with the Republic of Korea for an Agreement on the general principles for the participation of the Republic of Korea in Union programmes and on the association of the Republic of Korea to Horizon Europe – the Framework Programme for Research and Innovation (2021-2027)  - Adoption

- 1. On 20 March 2023, the <u>Commission</u> submitted to the Council a recommendation for a Council decision authorising the opening of negotiations with Republic of Korea on behalf of the European Union for the conclusion of an Agreement between the European Union, of the one part, and Republic of Korea, of the other part, on the participation of Republic of Korea in Union programmes and of a protocol on the association of Republic of Korea to Horizon Europe the Framework Programme for Research and Innovation (2021-2027)<sup>1</sup>.
- 2. The decision will allow the Commission to open negotiations with Republic of Korea on its participation to Union programmes and in particular to Horizon Europe.

- 3. The Commission presented the text to the <u>Research Working Party</u> and to the <u>Asia-Oceania</u> Working Party. Both Working Parties examined the text.
- 4. The <u>Research Working Party</u> agreed on the text following written consultation that was concluded on 4 April 2023. The <u>Asia-Oceania Working Party</u> agreed on the text following written consultation that was concluded on 3 April 2023.
- 5. The draft decision specifies that the role of the special committee, which the <u>Commission</u> has to consult during the negotiations with Republic of Korea in accordance with Article 218(4) TFEU, should be exercised by both the <u>Asia-Oceania Working Party</u> for matters related to the general conditions for the participation of Republic of Korea in any Union programmes and the <u>Research Working Party</u> for matters related to the specific conditions for the participation of Republic of Korea to the Horizon Europe programme.
- 6. In view of the above, the <u>Permanent Representatives Committee</u> is invited to recommend that the Council, in part "A" of the agenda of a forthcoming meeting, adopts the Council decision authorising the opening of negotiations with the Republic of Korea for an Agreement on the general principles for the participation of the Republic of Korea in Union programmes and on the association of the Republic of Korea to Horizon Europe the Framework Programme for Research and Innovation (2021-2027), as revised by the lawyer-linguists and set out in document 8154/23 and the negotiating directives as set out in document 8154/23 ADD 1.
- 7. The European Parliament will be informed in accordance with Article 218(10) TFEU and the Decision and the negotiating directives will be transmitted to the EP.
- 8. The Council decision will be published in the Official Journal in accordance with Article 17(2)(b) of the Council's Rules of Procedure.
