1. On 20 April 2023, the Commission submitted to the Council proposal for transfer of appropriations No DEC 06/2023 on the mobilisation of the European Globalisation Adjustment Fund (EGF/2023/000 TA 2023 – Technical assistance at the initiative of the Commission)<sup>1</sup>, in accordance with Article 31(1) of the Financial Regulation<sup>2</sup>.

2. The purpose of this transfer is to move an amount of EUR 190 000 in commitment appropriations from Article 30 04 02 (*Reserve for the European Globalisation Adjustment Fund for Displaced Workers (EGF)*) and an amount of EUR 190 00 in payment appropriations from Article 16 02 02 (*European Globalisation Adjustment Fund for Displaced Workers (EGF)*) to Article 16 01 01 (*Support expenditure for the European Globalisation Adjustment Fund for Displaced Workers*), as set out in 8489/23.
3. The Budget Committee examined this proposal for a transfer at its meeting on 11 May 2023.
4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
  - the proposed transfer of appropriations, as set out in 8489/23, and
  - the draft letter in the ANNEX to that effect.
