Dear **DELETED**,

Thank you for your request for access to documents of the Council of the European Union.¹

You requested "access to all minutes of the selection board taken during [your] interview", being understood that this includes "minutes/notes taken by the members of the selection panel" and "minutes recorded in electronic format".

I should clarify that when the Selection Board drafts "minutes", these are formal documents that never refer to the assessment of individual candidates. In any case, no such minutes exist concerning the day of your exam.

Selection panel members do, however, fill in individual "evaluation grids" for each candidate. Irrespective of their digital or paper format, they are kept by the General Secretariat of the Council in a secure place with strictly limited access.

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

These evaluation grids are indeed covered by the secrecy of proceedings of the Selection Board mandated by the Staff Regulations.²

Thereby the legislator itself has provided for such secrecy and it is to be presumed that release would seriously undermine the institution's decision-making process, without there being an overriding public interest in release in this regard.³

While there thus is such an evaluation grid covered by your request, the General Secretariat therefore has to refuse access to it.

We have also looked into the possibility of releasing parts of the document.⁴ However, as the exception to the right of access applies to its entire content, the General Secretariat is also unable to give partial access to it.

No other documents have been identified as covered by your request.

Pursuant to Article 7(2) of Regulation (EC) No 1049/2001, you may ask the Council to review this decision within 15 working days of receiving this reply. Should you see the need for such a review, you are invited to indicate the reasons thereof.

Dear Mr Florindo,

Thank you for your response to my request of 31.03.2023. I hereby apply for the review of the decision (Ref. 23/1103-ws/nb) setting out below the reasons for my request.

Refusal to my request was justified with the statement that "[...] no [...] minutes exist concerning the day of [my] exam" and that panel members only "fill[ed] in individual 'evaluation grids' for each candidate". I should point out that there is a factual error in this response. The fact is that one member of the selection board was charged with recording candidates' answers throughout the interview. That member had no active role in the process, i.e. posed no question, but solely recorded in writing candidates' responses. This is a fact acknowledged by all colleagues who took part in the competition. Releasing these notes, which are not covered by the secrecy of proceedings, would not undermine the institution's decision-making process.

Secondly, according to your response, you "have also looked into the possibility of releasing parts of the document. However, as the exception to the right of access applies to its entire content, the General Secretariat is also unable to give partial access to it." It is clear from the wording that the examination of the possibility of partial access to the requested document was not carried out in the light of the principle of proportionality. If the aim pursued by the Council in refusing access to the requested document is the protection of institution's decision-making process, this could be achieved by merely sticking out the passages which might harm this process. By refusing access to the entire content, it is impossible for me to confirm that my grades correspond indeed to the answers actually given by me during the exam.
