1. Council of Europe's 4th Summit (Reykjavik, 16-17 May 2023): main outcomes relevant to the meeting, follow up regarding EPA register of damages (CoE – EU)
2. Russian war of aggression against Ukraine and cessation of Russian membership in the CoE: cooperation in the criminal law field, investigations on war crimes, participation of Russia in CoE Conventions (EU-CoE)
3. European Public Prosecutor's Office (EPPO) and the 1959 CoE MLA Convention, including recognition of the EPPO as a judicial authority under the 1959 MLA Convention (CoE-EU)
4. Money laundering – terrorism financing – sanctions violation and confiscation of assets: latest developments (EU-CoE)
5. EU accession to CoE Conventions: ECHR, Istanbul, ... and to GRECO (EU-CoE)
6. Promotion by the EU of the CoE conventions in third countries (EU-CoE)
7. Information on the priorities of the CoE Chairmanship Committee of Ministers and of the incoming EU Presidency (CoE-EU)
