Subject: Confirmatory application for access to documents

Dear Council of the European Union, dear Mr. Florindo,

I officially submitted an application for access to documents under the terms of the Regulation (EC) No 1049/2001 of the European Parliament and of the Council of 30 May 2001 regarding public access to European Parliament, Council and Commission documents (the "**Regulation**") to the Council of the European Union on May 5, 2023. In my aforementioned application, I have requested access to 11 pcs of documents.

I have received your response on May 11, 2023 with the reference number of "Ref. 23/1349-ws/ef". You provided access to 5 pcs of documents attached to your response, these documents cover points (1), (2), (3) and (8) of my application.

Otherwise, you noted that you cannot provide access to the documents referenced in points (9) and (10) of my application by stating that "*there are no minutes, outcome of proceedings or other kind of report concerning the meetings of 22 and 28 September 2022 of the Budget Committee*".

As to the other requested documents, you stated that "[t]he Council does not hold any of the other documents mentioned in your request. In this regard, as already indicated in our email of 5 May 2023, you may wish to address a request for access to the European Commission."

I cannot accept your response and your partial refusal, therefore I hereby submit this confirmatory application under Art. 7(2) of the Regulation asking the Council to reconsider its position for the following reasons:

With respect to the documents allegedly not held by the Council, I refer to Art. 2(1) and Art. 2(3) of the Regulation:

*"(1) Any citizen of the Union, and any natural or legal person residing or having its registered office in a Member State, has a right of access to documents of the institutions, subject to the principles, conditions and limits defined in this Regulation.*

*(3) This Regulation shall apply to all documents held by an institution, that is to say, documents drawn up or received by it and in its possession, in all areas of activity of the European Union."*

According to the above-cited provisions, institutions shall provide access to those documents as well, which were not drawn up by the given institution but received by it for any reason. The Council adopted the Implementing Decision (EU) 2022/2506 of 15 December 2022 on measures for the protection of the Union budget against breaches of the principles of the rule of law in Hungary (the "**Implementing Decision**") based on the recommendations, proposals and documents received from the European Commission. Therefore, I assume that the Council received and assessed every related document before the adoption of the Implementing Decision.



As to the requested minutes of the Budget Committee, I argue that even if there are no formal minutes or reports of the concerned meetings, there must be at least some notes on the decisions adopted by the Budget Committee, from where its opinion can be learned.

Therefore, I maintain my application for documents sent to you on May 5, 2023 as to the documents to which access has been refused and I hereby submit this confirmatory application to request the Council to reconsider its position.

As provided for in Art. 10(1) Regulation, I request to have access to the documents referred to in my original application submitted on May 5, 2023 in the original language by receiving them in electronic copy in Word or PDF format by email to [REDACTED]@nt.hu.
