Joint Declaration by the Representatives of the Government of Japan and the European Atomic Energy Community for the Further Joint Implementation of the Broader Approach Activities

The Representatives of the Government of Japan and the European Atomic Energy Community (hereinafter referred to as “EURATOM”),

Share the following recognition:

1. The Government of Japan and EURATOM recognise the successful joint implementation of the Broader Approach (hereinafter referred to as “BA”) Activities in the Field of Fusion Energy Research carried out under the Agreement between the Government of Japan and the European Atomic Energy Community for the Joint Implementation of the Broader Approach Activities in the Field of Fusion Energy Research, signed at Tokyo on 5th February 2007 (hereinafter referred to as “the Agreement”) and the benefit that the BA Activities have brought to the ITER Project.
2. The Government of Japan and EURATOM reaffirm their determination to continue the cooperation under the Agreement; and recognise the need to supplement the Joint Declaration by the Representatives of the Government of Japan and EURATOM for the joint implementation of the Broader Approach Activities, Brussels, of 22nd November 2006 (hereinafter referred to as “the 2006 Joint Declaration”);
3. The Government of Japan and EURATOM will make additional contributions to those already made under the 2006 Joint Declaration for the further joint implementation of the BA in accordance with the **“Common Understanding on Contribution to the Broader Approach Activities”** annexed to this Joint Declaration, subject to the laws and regulations of Japan and of EURATOM in compliance with the respective administrative procedures and within the limit of the respective budgetary appropriations.

Common Understanding on Contribution to the Broader Approach Activities

From April 2020 onwards, the Government of Japan and the European Atomic Energy Community (EURATOM) will make additional contributions to those made under the 2006 Joint Declaration for the further joint implementation of the BA Activities under the Agreement in the territory of Japan.

On an annual basis, the Government of Japan and EURATOM will make these contributions for a value of up to fifty thousand Broader Approach Units of Account (BAUA). At the termination of the Agreement, the total of the additional contributions of the Government of Japan and EURATOM will be equal.

In addition to the annual contributions specified above, the Government of Japan, as Host, will provide on an annual basis and at its own expense goods and services required for the further joint implementation of the BA Activities under the Agreement. This contribution will have a value of no less than two thirds of its aforementioned total contribution.
