Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision of 22 July 2003² setting up an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- (1) By its Decisions of 24 February 2022³ and 29 March 2022⁴, the Council appointed members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2025.
- (2) A seat as alternate member in the employers' representatives category has fallen vacant as a result of the resignation of Mr Martin RÖHRICH.
- (3) The government of Czechia has nominated a candidate for the vacant seat,
