1. The General Secretariat of the Council has been informed of the resignation of Mr Corneliu CONSTANTINOAIA as alternate member of the above Committee in the trade unions' representatives category (for Romania).
2. Under Article 3 of Council Decision of 22 July 2003 setting up an Advisory Committee on Safety and Health at Work ¹, members and alternate members are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision of 22 July 2003² setting up an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- (1) By its Decision of 24 February 2022³, the Council appointed members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2025.
- (2) A seat as alternate member in the trade unions' representatives category has fallen vacant as a result of the resignation of Mr Corneliu CONSTANTINOAIA.
- (3) The government of Romania has nominated a candidate for the vacant seat,
