Subject:	Management Board of the European Institute for Gender Equality: Appointment of Ms Rita NAGYLAKI, member for Hungary, in place of Ms Brigitta GYEBNÁR, who has resigned

---

1. The General Secretariat of the Council has been informed of the resignation of Ms Brigitta GYEBNÁR, as member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Hungary).
2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006<sup>1</sup> provides, inter alia, that the Council should appoint eighteen members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years. The appointed members and alternate members represent eighteen Member States in the order of the rotating Presidencies, one member and one alternate member being nominated by each Member State.
3. By its Decision of 24 May 2022<sup>2</sup>, the Council appointed the members and alternate members for the period ending on 31 May 2025.

Whereas:

- (1) By its Decision of 24 May 2022<sup>4</sup> the Council appointed the members and alternate members of the Management Board of the European Institute for Gender Equality, for the period ending on 31 May 2025.
- (2) A member's seat in the government representatives category has fallen vacant as a result of the resignation of Ms Brigitta GYEBNÁR.
