INTRODUCTION

On 30 January 2020, the Director General of the World Health Organisation (WHO) declared the COVID-19 outbreak a Public Health Emergency of International Concern. Although the spread of the outbreak is still very centred in China, cases have been reported in several countries in different regions. According to the WHO, there is a high risk that the COVID-19 continues to spread to other parts of the world. The spread of the epidemic to and within countries with weak healthcare systems - notably in Asia and Africa - is a major concern. Africa is the region least prepared for managing epidemics globally. Similar to seasonal influenza, the spread of the COVID-19 is difficult to control. A pandemic spread of the COVID-19 should (and must) be anticipated, in line with the declaration by the WHO, categorizing the current outbreak a Public Health Emergency of International Concern.

To respond to this high risk of spread of the COVID-19, on 5 February 2020, a USD 675 million Strategic Preparedness and Response Plan for the COVID-19 was launched, which defines activities and resources needed by international health organizations globally, including the WHO.

The present transfer proposes to mobilise EUR 30 million in commitment appropriations and EUR 24 million in payment appropriations for this crisis, in addition to EUR 32 million of existing contracts, which will be adapted to redirect part of the funding to preparedness for epidemic surveillance. It will contribute to strengthening epidemic preparedness and response through the WHO Strategic Preparedness and Response Plan (SPRP).

As of the end of February, the overall implementation rate of commitment appropriations of the humanitarian aid chapter 23 02 was at 94,5% of available appropriations and the implementation in payment appropriations was at 9,7%. The Operational Reserve for Humanitarian aid currently stands at EUR 85 million and due to the urgency of this crisis, will be used to front load the funds for this purpose. However, the funds need to be preserved to cater for other, smaller humanitarian emergencies or sudden disasters between now and year end.

The Commission has not been able to identify other available resources in Heading 4. Therefore, it requests the mobilisation of the Emergency Aid Reserve for a total of EUR 30 million in commitment appropriations and EUR 24 million in payment appropriations for the COVID-19 outbreak crisis.
