The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

Disclosure of this information would undermine the protection of privacy and the integrity of the individual in question, in particular in accordance with European legislation regarding the protection of personal data.² Accordingly, pursuant to Article 4(1)(b) of the Regulation (EC) No 1049/2001 (protection of privacy and the integrity of the individual), the General Secretariat is unable to grant you access to these parts of the documents³.

However, as abovementioned, pursuant to Article 4(6) of the Regulation, you may have access to the rest of the documents which is not covered by this exception.

Dear Council of the European Union,

Please pass this on to the person who reviews confirmatory applications.

I am filing the following confirmatory application with regards to my access to documents request 'Documents concerning access to documents request Ref 23/1517mj-adb/el'.

There is reason to assume that not all documents within the scope of my request were released. The Council claims that a "careful assessment" of the documents within the scope of the request 23/1517mj-adb/el" was made, yet no documents stemming from this assessment were released. This runs contrary to any proper administrative work.

Council should stop using an arbitrarily narrow definition of what constitutes a document under Regulation 1049/2001 that seems to include notes, drafts and internal exchanges of documents or parts thereof.
