- information regarding Andrea Venegoni;

## Dear **DELETED**,

Thank you for your request for access to documents of the Council of the European Union.<sup>1</sup>

We have identified the following documents as related to your request:

- 12175/19 Appointment of European Prosecutors Internal process to be followed within the Council (dated 18/09/2019);
- 9878/23 CVs and motivation letters of the Italian candidates (dated 26/05/23)
   (RESTREINT UE/EU RESTRICTED);
- 10037/23 written remarks submitted by Italy in relation to the ranking and reasoned opinion of the selection panel with respect to the merits of the candidates it nominated; (dated 1/06/23) (RESTREINT UE/EU RESTRICTED);
- 10037/23 ADD1 reasoned opinion of Consiglio Superiore della Magistratura of 21 July 2022 on the establishment of the list of three Italian candidates for the post of European Prosecutor (dated 5/06/23) (RESTREINT UE/EU RESTRICTED);

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

- 10237/23 the note to CRP/Council on the EPPO: partial renewal of the College -Appointment of eight European Prosecutors – 2023 (dated 16/06/23);
- 10251/23 the Council Decision appointing the European Prosecutors of the European Public Prosecutor's Office (dated 16/06/23).

You will find enclosed documents 12175/19, 10237/23 and 10251/23.

I regret to inform you that for the reasons set out below, access to documents **9878/23**, **10037/23** and **10037/23 ADD1** cannot be granted.

These documents are classified documents, bearing the classification "RESTREINT UE/EU RESTRICTED". This means that the unauthorised disclosure of their contents could be disadvantageous to the interests of the European Union or of one or more of its Member States.<sup>2</sup> Access to these documents should therefore be refused as classified documents and in order to protect the confidentiality of the decision-making process<sup>3</sup> that led to the appointment decision of the Italian nominee, including Italy's written remarks thereon, the commercial interests<sup>4</sup> and the personal data<sup>5</sup> of the persons concerned.

Pursuant to Article 7(2) of Regulation (EC) No 1049/2001, you may ask the Council to review this decision within 15 working days of receiving this reply. Should you see the need for such a review, you are invited to indicate the reasons thereof.

Dear Sir or Madam.

I hereby submit a confirmatory application pursuant to Regulation (EC) No 1049/2001 and request

that the Council's position on the applicability of exceptions be reconsidered.

The mere fact that a document is classified as RESTREINT UE/EU RESTRICTED does not mean

that the right of access to documents is excluded. The Council would have to explain in detail the

contents of the documents and why such contents are covered by the exceptions set out in

Article 4(1 to 3) of Regulation (EC) No 1049/2001. If only parts of a given document were covered

by one of the exceptions, the rest of that document would have to be released, as is clear from

Article 4(6).

My application also demonstrates the existence of a particular public interest. However, your letter

does not indicate that you have weighed the public interest in disclosure of the requested documents

against the interests of the Council or third parties meriting protection.

In this respect, access to the documents classified as RESTREINT UE/EU RESTRICTED will – at

least to a large extent –also have to be granted.
