As regards the “Agriculture and Fisheries” Council meeting on 18 September 2023:

- the Slovenian delegation requested an item under “any other business” on the damage caused to agriculture by the extreme floods in early August.
- The Danish delegation requested an item under “any other business” on Simplification and Better Regulation in EU Common Policies on Food, Agriculture and Fisheries.
- The SCA subsequently agreed that these items would be held in public session in accordance with article 8(2) of the rules of procedure of the Council.
